

VACATION SWEEPSTAKES OFFICIAL RULES

1. No purchase necessary to enter or win. A purchase does not improve your chances of winning. Open to legal residents of the continental US only, who are at least 18 years of age as of April 9, 2009. All applicable federal, state, and local laws and regulations apply.

Employees of Signature Travel Network and their respective affiliates, suppliers, advertising agencies, and their families, and persons living in the same household as such employees, are not eligible to participate. Void wherever prohibited by federal, state, or local laws.

2. How to play: Enter by completing the online entry form. The Sweepstakes runs from 12:00 a.m. Pacific Standard Time ("PST"), January 1, 2009 through 11:59 p.m. PST, April 9, 2009 (the "Sweepstake Period"). All entries must be received by 11:59 p.m. PST on April 9, 2009. One entry per person/e-mail address/mailling address only. Online entries will be deemed made by the authorized account holder of the e-mail address submitted at the time of entry.
