

VACATION SWEEPSTAKES OFFICIAL RULES

- 1. NO PURCHASE NECESSARY to enter or win. A purchase does not improve your chances of winning.** Open to legal residents of the United States and all providences of Canada except for Quebec. For U.S. residents, all applicable U.S. federal, state, and local laws and regulations apply. For Canadian residents, all applicable Canadian federal, state, and local laws and regulations apply. Employees of Signature Travel Network and its member agencies, and their respective affiliates, advertising agencies, and their families, and persons living in the same household as such employees, are not eligible to participate.
